ORDINANCE NO. 2, AMENDED

ORDINANCE:

Be it ordained by the Town Council of Interlaken Town as follows:

- A. At its June 8, 2015 Council Meeting, the Council did approve a moratorium on the issuance of Building Permits until the Town's land use codes have been adopted.
- B. The Council now wishes to amend this Ordinance No. 2 to allow interior remodels.
- H. Effective Date: This ordinance shall become effective upon publication of a summary in a newspaper or 20 days after adoption, whichever shall be first.




